# **27 CASES OF CASH PROGRESSIVE GIVEAWAY RULES**

# Every Thursday from January 2 through July 3, 2025

# Eligibility:

- Must be age 21 or older and a Rising Star VIP Club member (VIP Club/Card/Member/Account).
- Any employee of Rising Star Casino Resort (RSC) and Gaming Entertainment (Indiana) LLC, which is a
  wholly owned subsidiary of Full House Resorts, Inc, employees of participating vendors, plus any IGC
  employee/agent/commissioner and/or spouse may not participate.
- Immediate family members (which include spouse, mother, father, brother, sister, or children plus mother-in-law or father-in-law) of any Level 1 or promotion-related Level 2 occupational licensees (promotion-related Level 2 occupational licensee means the immediate family member is employed in one of the following departments: Information Technology, Marketing, Promotions Administration, Surveillance, or any other department that the Commission determines may affect the outcome of a promotional event) are not eligible to win a promotional prize valued at \$1,000 or more.

# Prizes Awarded On All Thursday Event Dates EXCEPT July 3:

- Every 30 minutes from 4 pm 7:30 pm, (2) winners collect \$100 Free Slot Play (FSP).
- At 8 pm, (1) Cases winner and (2) alternates are selected. At the Promo Booth, the Cases winner picks a
  Case Of Cash envelope from the game board for a chance at the progressive cash jackpot. The alternates
  collect \$100 FSP each. (See July 3 Event Date below for an exception at 8 pm.)
- For the first event date of the promotion (January 2) and for the first event date which follows the
  progressive being won, there are 27 sealed, identical envelopes: 26 contain a certificate with varying

FSP amounts: (13) \$100, (12) \$200 and (1) \$500. (1) envelope has the "Jackpot" certificate. The progressive cash jackpot starts at \$2500.

- If the Cases winner opens an FSP envelope, the winner gets the value shown, the case is removed from the board leaving 1 fewer case, and the cash progressive increases by \$2500 for the following Thursday.
  - Example: Should the progressive not be won on January 2, there are 26 envelopes left and a \$5000 progressive cash jackpot for January 9.

# Prizes Awarded at 8 pm on the Final Event Date of July 3:
